Item No.2: Amendment in Ordinance Chapter XVI Clause 16.12(IV) for admission to Ph.D. in Management.


The Board of Studies approved the amendment in Ordinance Chapter XVI Clause 16.12 (IV) for admission to Ph.D in Management, proposed as under to be applicable from the session 2018-19:

Existing	Proposed
<p>IV. For Ph.D. in Management Studies, the basic qualification for registration/ admission shall be Master's degree in Business Administration/ Management Studies/ International Business Management/ Finance and Control/ Personal Management/ Tourism Administration / Economics / Public Administration / Psychology / Commerce / Computer Application / Information Technology / Professionals with executive experience of 3 years or more will get 10% weightage of the marks scored in the entrance test for admission to Ph.D. For this purpose only those executives working in Government Organizations, autonomous statutory Corporations or Boards, Public or Private Sector Companies, registered as per the Companies Act would get this weightage.</p>	<p>IV. In Management Studies basic qualification for registration to Ph.D. programme shall be Two Years Master's degree in Business Administration/ Management Studies / International Business Management / Finance and Control/ Human Resource Management/ Personnel Management/ Tourism Administration with at least 55% marks (50% marks for SC/ST candidates). Being a professional degree direct admission to the Ph.D. programme would be made for JRF qualified candidates. In case the seats remain vacant NET qualified candidates would be considered for direct admission. If the seats still remain vacant, applicants will be required to appear for the entrance test to be conducted by H. P. University. Candidates with 10 years of Corporate Executive experience will be exempted from appearing in entrance test for admission to Ph.D. in Management Studies. Other terms & conditions shall remain as per the guidelines issued by U.G.C. and adopted by H.P. University from time to time.</p>


Item No.3: Revision of MBA Syllabus Course No. 105 Indian Ethos and Values.




