Subject: Regarding admission to BDS course for the academic session 2020-21.

Sir/Madam,

The provisional allocation of seats during the 2nd mop-up round of online counselling have been made by the Centralized Counselling Committee to those candidates who had applied online within stipulated period on the basis of the Choices/Preferences filled by the candidates in the online application form. Therefore, I am directed to send herewith a list of the candidates who have been allocated seats provisionally college-wise as well as category-wise in order of merit-cum-choices/preferences of the colleges/quota filled, in the online application form by the candidates as per fresh merit drawn by the University on the basis of NEET-UG-2020 for provisional admissions to BDS course in the respective Government and Private Dental Colleges for the academic session 2020-21 **(Annexure-A)** against the vacant/resultant seats under State Quota/Management Quota as per vacancy position intimated by you. However, the allocation of seats to the colleges concerned for admission to the aforesaid course is provisional and subject to final verification of eligibility criteria with reference to all requisite original certificates/documents by the Admission Committee of the college concerned and further medical fitness as well as completion of other pre-admission requirements as per provisions of the prospectus. The print out of the online application form along with all requisite certificates/documents duly self-attested may kindly be obtained along with Provisional Allotment Letter from the candidates concerned while verifying the eligibility criteria by the Committee of the college and the same may be kept for the record. Before granting admission to the candidates, the eligibility criteria may kindly be ensured strictly as per provisions of the prospectus. The SOP's issued by the Government of India and State Government may be strictly followed during admission process.

2. The candidates who have been allocated seats for admissions to BDS course have been issued provisional allotment letters, which have been uploaded on the University website www.hpuniv.ac.in or visit URL:<http://hp.online-counselling.co.in/> and they have been directed to report in person to their respective allocated colleges **on 18.01.2021 at 10.00 AM** for completing all pre-admission requirements as per provisions of the prospectus along with remittance of fee, failing which their claim for admission shall stand forfeited/cancelled. However, candidate (s) who is not able to report in person to the allocated college due to COVID-19-Pademic(Home-Quarantine or Containment Zone), he/she may depute authorized representative with documentary proof of COVID-19/Containment Zone and authority letter along with all requisite documents as per provisions of the prospectus.

3. The candidates who have been allocated seats afresh during the mop-up round of online counselling, their token amount of fee as mentioned in the prospectus under Clause –VIII.2(a) at page-35-36 may kindly be adjusted in their tuition fee, as the same has been deposited with the University. The aforesaid token amount shall be transferred by the University to the concerned colleges after completion of admission process.

4. The candidates those already admitted on the basis of previous rounds of online counselling in private dental colleges to BDS course and now upgraded/shifted to Govt. Dental College during this mop-up round of online counselling on the basis of their choices/preferences are required to report directly in the new allocated college for admission along with fee deposition receipt or any other proof of admission in the previous joined college in the first instance. Their amount of fee and other dues so deposited shall be transferred along with their admission record to the new allocated college by the authorities of the previous college. However, the difference amount of fee shall be deposited by the candidate on the day of admission in the college.

5.. The complete updated list of all admitted candidates with full particulars may kindly be sent to the University by e.mail: arentrancetests919@gmail.com on 18.01.2021 upto 5 PM and also update the same in the online link provided in the college e.mail account.

6. The candidates who have passed their 10+2 examination other than HP Board of School Education, Dharamshala/CBSE/ICSE, the equivalence certificate to this effect may be obtained from such candidates.
