**NOTICE FOR 2<sup>nd</sup> ROUND OF ONLINE COUNSELLING FOR FILLING UP THE VACANT SEATS OF BAMS/BHMS COURSES IN GOVERNMENT/PRIVATE AYURVEDIC AND HOMEOPATHY COLLEGES FOR THE ACADEMIC SESSION-2021-22.**

In continuation to this office letter of even No. dated 08.02.2022 whereby the schedule for 2<sup>nd</sup> round of online counselling was issued and displayed in the website of the University. Now, the aforesaid schedule has been revised as per the guidelines issued by the Govt. of India, Ministry of Ayush vide letter No. L-14030/12/2022-EP-1 dated 17.02.2022. In view thereof, all the interested candidates whose names are figured in the HPU Merit List of all categories (which is already available on the University website) **are required to apply ONLINE with requisite token amount of fee of Rs. 25,000/- + Rs. 100/- as counselling fee for the 2<sup>nd</sup> round of online counselling to fill up the online application form with fresh choices/preferences of colleges and quota w.e.f. 23.02.2022 to 09.03.2022 (upto 11:59 PM) on the University website [www.hpuniv.ac.in](http://www.hpuniv.ac.in) & URL: <https://www.onlinesbi.com/sbicollect/icollecthome.htm> for filling up the vacant/resultant seats as per provision contained under Clause-9.3 at page-22 of the prospectus for admission to BAMS/BHMS courses under State/All India Quota in Government and Private Ayurvedic Colleges including Private Homeopathy College for the academic session 2021-22. **The tentative vacancy position is attached herewith at Annexure-A.** Candidates allocated seats during the 1<sup>st</sup> round of online counseling, but not joined the allocated college may also apply, if they are interested. However, the shifting for up-gradation from one college to another colleges and course/quota shall also be allowed during the 2<sup>nd</sup> round of online counselling in order of merit-cum-choices/preferences of the colleges as per provisions of the prospectus for which the candidates can also apply online. The following conditions are applicable :-**

- (a) The candidates those applied online within the stipulated period, their fresh merit list shall be drawn by the University and the same shall be uploaded on the University website on **15.03.2022** along with list of provisional allocation of seats for admission against vacant/resultant seats of State/ All India Quota in the aforesaid Ayurvedic/Homeopathy colleges. The aforesaid allocation will be made by the Centralized Counselling Committee strictly in order of merit-cum-choices/preferences of the college/course filled by the candidates in the online counselling form, which is further subject to availability of seats and fulfilment of prescribed eligibility criteria of the prospectus. Merely filling up the online counselling form does not confer any right for admission. However, the candidates will be allotted seats provisionally on the basis of fresh merit list to be drawn by the University and they shall have to report to the concerned allocated college on 17.03.2022, failing which their claim for admission shall be forfeited/cancelled.
- (b) It is pertinent to mention here that the candidates can fill the choices of colleges & quota which are not reflecting in the vacancy position of seats, as few seats may arise due to shifting/drop-out/casual vacancy, if any, during this round of online counselling. Hence, it is not mandatory to fill only those choices/preferences, which are reflected in the aforesaid vacancy position of seats. Therefore, candidates are advised to fill the preferences/choices of colleges as per their choice of maximum colleges. The seats will be allocated as per availability of seats as per fresh merit- cum -choices/preferences submitted by the candidates in the online application form in this round of counselling.
- (c) Candidates participating in the 2<sup>nd</sup> round of ONLINE counselling for admission to BAMS/BHMS courses against vacant/resultant seats in the Govt. and private Ayurvedic/Homeopathy Colleges are required to remit the token amount of fee of Rs.25,000/- (Rupees twenty five thousand only) as per provisions 9.3(b) of the prospectus alongwith counseling fee of Rs. 100/- as while filling-up their online counselling form as per their choices/preferences of college & quota, failing which no seats shall be allocated to them and their online form shall have to be treated as incomplete/rejected. However, the candidates already admitted during the 1<sup>st</sup> round of online counselling in the Private

Ayurvedic/Homeopathy Colleges are not required to remit the token amount of fee, whereas they shall remit Rs.100/- only as counselling fee.

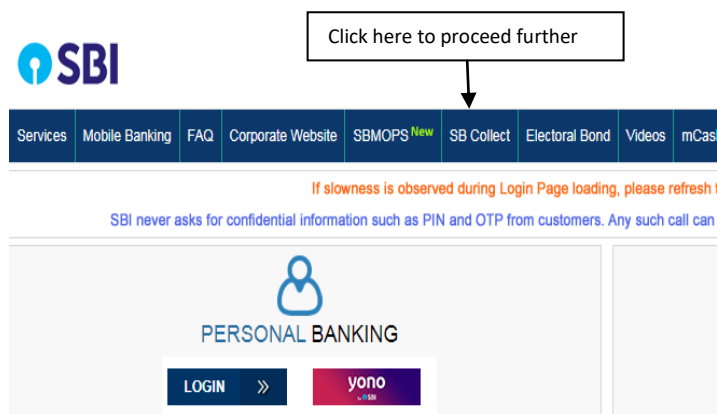
(d) **Candidates who will be allocated seats provisionally and reported for admission to BAMS/BHMS Courses, their token amount of fee shall be adjusted in the tuition fee amount by the allocated colleges concerned. The candidates those will not be allocated seat their token amount of fee shall be refunded as per the provisions of the prospectus. If the candidates allocated seats during this round of online counselling and do not report for admission in the allocated college, their token amount of fee shall be forfeited as per provision 9.3(b) at page-22 of the prospectus.**

(e) In view of the above, the candidates who are interested for seeking admission to BAMS/BHMS courses in Govt. and private Ayurvedic/Homeopathy colleges may apply online for 2<sup>nd</sup> round of online counselling within stipulated period.

**Important Instructions for**

**Apply for online counseling of BAMS/BHMS Courses  
& depositing the token amount of fee for the academic session 2021-22**

Candidates are directed to apply online for the Counseling of BAMS/BHMS courses on the University website [www.hpuniv.ac.in](http://www.hpuniv.ac.in) by *Clicking on the Link: **Apply ONLINE COUNSELING for BAMS/BHMS Courses*** OR directly visit [www.onlinesbi.com](http://www.onlinesbi.com). After clicking on aforesaid link a new window of SBI Bank will be open, thereafter **you have to Click on SBI-Collect** (Screenshot of link is shown below) then follow the below mentioned steps for ONLINE Counseling fee payment:-



**Step 1**

- a) State of Corporate/Institution: <Select> **Himachal Pradesh**
- b) Type of Corporate/Institution: <Select> **Educational Institution**

**Step 2**

- a) Educational Institution Name: <Select> **Finance Officer, HP University, Shimla**

**Step 3**

- a) Select One Payment Category: <Select> **2<sup>nd</sup> Round counseling BAMS/BHMS**

**Step 4**

Enter all the details accurately as per the fields given on the present screen, all these fields are mandatory to fill for making the ONLINE Counseling fee payment and based on this information your candidature will be considered provisionally for allotting the college of your choice.

**Step 5**

Once you **Confirm** the 'payment details', three modes of payment are there i.e. **1) Net Banking 2) Card Payment (By Using Debit/Credit Card) 3) Other Payment modes**. Candidates are advised to use the option of Card payment only. In case of Net Banking and Card payment, e-receipt will be generated on the website only in pdf format. Applicants are directed to immediately take the print out of that e-receipt and retained the copy of the same for future reference.

**After making the ONLINE payment your application for ONLINE Counseling will be completed.**

While applying for ONLINE Counseling at Step-4 of the aforesaid process, the candidate has to give the Choices/preferences of 4 Colleges where the candidate wants to seek

admission. The list of the BAMS/BHMS Colleges as appeared in the drop down of the application is given here under with complete address and contact Number. If Candidate is having any query pertaining to College or regarding hostel fee, transportation Charges & Other dues then they can directly contact the concerned college.
