NOTICE FOR 2nd MOP-UP ROUND OF ONLINE COUNSELLING FOR FILLING UP THE VACANT SEATS OF BDS COURSE UNDER STATE/MANAGEMENT/NRI QUOTA IN GOVERNMENT AND PRIVATE DENTAL COLLEGES FOR THE ACADEMIC SESSION-2020-21.

Pursuant to the directions received from the Director Medical Education & Research, H.P. vide letter No.HFW(DME)H(III)G-58/10-Vol-XIII dated 23.12.2020 and further as per decision taken by the Centralized Counselling Committee in its meeting held on 31.12.2020, all the interested candidates whose names are figured in the HPU Merit List of all categories (which is already available on the University website) along with fresh registration of qualified candidates of NEET-UG-2020 **are required to apply ONLINE with requisite token amount of fee for the 2nd mop-up round of online counselling to fill up the online application form with fresh choices/preferences of colleges and quota w.e.f. 08.01.2021 to 10.01.2021 (upto 11:59 PM) on the University website www.hpuniv.ac.in & URL: <https://hp.online-counselling.co.in> for filling up the vacant/resultant seats including drop-out/casual vacancy as per provision contained under Clause-VIII.3 at page-36 of the prospectus for admission to BDS course under State/Management/NRI Quota in H.P. Government Dental College, Shimla and Private Dental Colleges for the academic session 2020-21. **The tentative vacancy position is attached herewith at Annexure-A** The shifting for up-gradation of college from private Dental Colleges to Govt. Dental College, Shimla and one private dental college to another private dental college from Management Quota to State Quota seat only is allowed in order of merit-cum-choices/preferences of the colleges as per provisions of the prospectus for which the interested candidates may also applied online for mop-up round of counselling. Shifting for same quota seats from one private dental college to another private dental college is not allowed. The following conditions are applicable to the candidates for 2nd mop-up round of counselling:-**

- (a) The candidates those applied online within the stipulated period, their fresh merit list shall be drawn by the University and the same shall be uploaded on the University website on **12.01.2021** along with provisional allocation of seats for admission against vacant/resultant seats of State/Management/NRI Quota in the aforesaid dental colleges. The aforesaid allocation will be made by Centralized Counselling Committee strictly in order of merit-cum-choices/preferences of the college/course filled by the candidates in the online counselling form in the mop-up round of online counselling, which is further subject to availability of seats and fulfilment of prescribed eligibility criteria of the prospectus. Merely filling up the online counselling form for mop-up round does not confer any right for admission. However, the candidates will be allotted seats provisionally on the basis of fresh merit list and they shall report to the concerned allocated college **on 14.01.2021**, failing which their claim for admission shall be forfeited/cancelled.
- (b) It is pertinent to mention here that the candidates can fill the choices of colleges & quota which are not reflecting in the vacancy position of seats, as few seats may arise due to shifting/drop-out/casual vacancy, if any, during mop-up round of counselling. Hence, it is not mandatory to fill only those choices/preferences which are reflected in the aforesaid vacancy position of seats. Therefore, candidates are advised to fill the preferences/choices of colleges as per their choice of maximum colleges. The seats in 2nd mop-up round will be allocated as per availability of seats as per fresh merit- cum -choices/preferences submitted by the candidate in the online application form in the mop-up round of counselling.
- (c) Candidates participating in the 2nd mop-up round of ONLINE counselling for admission to BDS course against vacant/resultant seats in the Govt. and private Dental Colleges are required to remit the token amount as per provisions VIII.2(a) of the prospectus while filling-up their online counselling form as per their choices/preferences of college & quota, failing which no seats shall be allocated to them and their online form shall be treated as incomplete/rejected. However, the candidates already admitted during the previous rounds of online counselling in the Private Dental Colleges and other candidates who has already been

deposited the token amount of fee during the 2nd & 1st mop-up rounds of online counselling, but no seat has been allocated to them or candidates those who had not joined the allocated colleges

during the 2nd round of online counselling are not required to remit the following token amount of fee while filling-up the online counselling form for mop-up round of online counselling. However, candidates those allotted seats during the 1st mop-up round of online counselling, but not joined the college are again required to remit the aforesaid token amount of fee, as the previous token amount of fee has been forfeited as per the condition stated in the notice dated 31.12.2020. The details of the token amount of fee as per the provisions of the prospectus is as under:-

(i) Government Dental College = Rs. 20,000/-
(ii) Private Dental Colleges(State/Management/NRI Quota: Rs.50,000/-
(iii) Candidates those will apply afresh are also required to remit the following application form fee with aforesaid token amount of fee:-
(a) For General/NRI & Other Categories: : Rs.2000/-
(b) For SC/ST/Persons with Disability(PwD) Categories: Rs.1000/-

Note: No seat shall be allocated without remitting the aforesaid token amount of fee during the mop-up round of online counseling.

- (d) The provision as contained under clause-VIII.9(c) is hereby amended as per decision taken by the Centralized Counselling Committee keeping in view the non-seriousness of the candidates and in order to complete the admission process within time-bound schedule prescribed by the Dental Council of India for seeking admission to BDS course subject to the final approval of the State Government is as under:-

“Candidates those will be allotted seats to BDS course in the Government and private Dental Colleges during the mop-up rounds of online counselling and if they do not join the college/course within stipulated period, the token amount of fee of Rs.20,000/- and Rs.50,000/- (as applicable) shall be forfeited by the University. However, candidates those not allocated seats during the mop-up rounds of counselling, the aforesaid amount of fee shall be refunded to them without any deduction after completion of admission process tentatively within two months for which the candidates are required to apply on the prescribed format as per Appendix-27 of the prospectus. The University shall transfer the aforesaid token amount of admitted candidates to the colleges concerned after completion of admission process tentatively within two months.”

- (e) In view of the above, the candidates who are interested for seeking admission to BDS course in Govt. and private dental colleges may apply online for 2nd mop-up round of online counselling.
- (f) Candidates who will be allocated seats provisionally for admission to BDS Course, their token amount of fee shall be adjusted in the tuition fee amount by the allocated colleges concerned. The candidates those will not be allocated seat their token amount of fee shall be refunded as per the provisions of the prospectus.

Note: (i) Candidates are advised to fill up choices/preferences/quota very carefully and the seats can be increased/decreased. Therefore, candidates may apply for maximum choices/preferences of the colleges so that they may not loose their chance for admission.
