She shall submit the list of candidates having taken admission to the DME and R.H.P.-cum-Chairman Counselling Committee and COE, HPU-cum-Member Secretary Counselling Committee well before conduction of 2nd round of counselling. The eligibility criteria as per provisions of the prospectus must be checked before admitting the candidates.
