**Corrigendum with Reference to List of Provisional Allocation for admission to MBBS/BDS
Courses for the academic session 2020-21**

In continuation of this office notification of even No. dated 26th Nov., 2020 vide which the candidates who have been allocated seats provisionally college-wise as well as category-wise in order of merit-cum-choices/preferences of the colleges filled, in the online application form by the candidates as per merit drawn by the University on the basis of NEET-UG-2020 for provisional admissions to MBBS Course at MMMC Kumarhatti, Solan and for BDS Course in Government and Private Dental Colleges in the H.P. State for the academic session 2020-21, the factual error has been detected in the aforesaid provisional allocation list in respect of MMMC, Kumarhatti and HPGDC, Shimla under the Category Backward Area.
