



MEMORANDUM OF UNDERSTANDING

&
CAREER POINT UNIVERSITY, HAMIRPUR



This **MEMORANDUM OF UNDERSTANDING** entered into on this 12th day of October, 2021,

BETWEEN

Himachal Pradesh University, through its Hon'ble Vice Chancellor Prof (Dr.) Sikander Kumar for Himachal Pradesh University Institute of Legal Studies, having its campus at Ava Lodge Chaura Maidan Shimla, Himachal Pradesh, India (hereinafter referred to as "HPUILS" which expression shall mean and include, wherever the context so requires or admits, its successors-in-interest, administrators and executors) of the **First Part**.

AND

The **Career Point University**, Bhoranj (Tikar-Kharwarian), Hamirpur was established by the Government of Himachal Pradesh vide Act No 12 of 2012 under section 2(f) of the UGC Act, 1956. The University is empowered by the University Grant Commission (UGC), a statutory body of Government of India, for the award of degrees under Section 22 of the UGC Act 1956. The University is a member of the Association of Indian Universities (AIU). Through the Career Point University Act, 2012 through its Hon'ble Vice Chancellor Prof. (Dr) K S Verma for School of Legal Studies and Governance. (hereinafter referred to as "CPU" which expression shall mean and include, wherever the context so requires or admits, its successors-in-interest, administrators and executors) of the **Second Part**.

WHEREAS both the parties jointly hereinafter shall be referred to as the Parties and individually as the Party.

WHEREAS HPUILS and CPU mutually agree to cooperate on student engagement programs based on the principles of reciprocity.

OBJECTIVES

Both the Institutions of Himachal Pradesh University and Career Point University hereby agree to encourage academic cooperation through research and study in furtherance of the following objectives:

This MOU encourages the exchange of academic information and materials in the belief that the research and educational processes at both the institutions will be enhanced with the mutual understanding between their respective faculty, scholars and students by the establishment of such exchanges.

1. To organise joint research programs like seminars, conferences, workshops, FDP's and online/offline lectures on relevant themes.
2. To encourage visits by faculties from both the institutions for academic activities.
3. To promote students exchange programs

TERMS & CONDITIONS

1. The implementation of each specific exchange based on this MoU shall be subject to the prior permission of the concerned authorities and shall comply as per the directions/guidelines of the competent authorities of both the parties.
2. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by upon the other in carrying out the MoU.
3. This MoU shall be in force for five years from the date of signing and is subject to revision/modification or termination by mutual written consent by giving one month notice. Dispute if any shall be resolved amicably and the decision taken by the Hon'ble Vice Chancellors after meeting will be final for both the parties.
4. This MoU will come into force from the date of the signatures of the officers mentioned below.


Both the Universities agree that the MoU is incorporated into, and will provide the foundation and framework for academic development and enhancement of education


