The NEP 2020 envisions moving towards a higher educational system consisting of large. multidisciplinary universities and colleges and aims to create imaginative and flexible curricular structures promoting a credit-based system that encourages flexible, integrated, and multidisciplinary education thus, removing currently prevalent rigid boundaries and creating new possibilities for lifelong learning offering multiple entry and exit points.

In order to realize the vision of NEP 2020, an Academic Bank of Credit (ABC) has been established which digitally stores the academic credits earned from various recognized HEIs so that the degrees from an HEI can be awarded considering credits earned. To ensure the realization of the vision of NEP 2020, the role of Academic Institutions is critical by ensuring timely upload of credits to the APAAR credit repository and depositing them in the students' APAAR accounts. This is essential to facilitate

In an ideal scenario, all meademic instriutions affast appload credit information immediately post completion of assessments and declaration of results. However as per the information shared by National E-Governance Division (NEGD) in has been observed that the award granting Institutions onboarded on the ABC platform are not depositing credits in the students APAAR IDs in a timely manner which is defeating the very purpose for which ABC was envisaged.

Based on the Ministry of Education vide D.O. letter No. Tel 6-5/2020-TEL dated 29.07.2024. HEIs are informed that the last date for uploading of credit data on the ABC portal is 31th December, 2024. post which the HEIs shall not be allowed to deposit credits on the ABC eco-system.

You are requested to review the current status of your institution and ensure uploading of credit data

Sir/Madam,

This has reference to earlier e-mails on dated 22.03.2024 & 30.08.2024 on the above-mentioned subject. As per University records, many students who registered on the University portal during the academic sessions 2021-22, 2022-23 and 2023-24 after being admitted to colleges have not yet created their Academic Bank of Credits (ABC) IDs. Enclosed herewith is a course-wise list of such students from your institution who have not completed this mandatory process.

In this regard, you are kindly requested to instruct the students listed to create their ABC IDs, as it is compulsory. Please note that, from the academic session 2024-25 onwards, no student from affiliated colleges will be able to register of fill up the examination forms with the University without an ABC ID. It is also pertinent to mention here that while creating ABC ID on the Digi locker students are advised to select the name of the H.P. University, Shimla.

You are therefore requested to direct the NAD, Co-ordinators of your colleges to instruct the students of your college for the aforementioned academic sessions to complete the process on and submit the complaint by before 26<sup>th</sup> December, 2024 to computercentreofficehpu@gmail.com., The University has provided the following URL to facilitate the process: <a href="mailto:nrme.hpushimla.in">nrme.hpushimla.in</a>. Compliance with this requirement is mandatory as per the UGC (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulations, 2021 on or before 31<sup>st</sup> December 2024.
