The online application forms for the regular students of Post-Graduate Diploma and Degree courses BHM, B.A.LL.B. shall be verified after determining the eligibility conditions as well as the attendance by the Chairpersons/Directors of the concerned Departments/Institutes or the Principals of the Colleges concerned as the case may be. In case of ICDEOL students the online examination forms after determining the eligibility should be verified by the ICDEOL. Thereafter the hard copies of the forms along with certificates should immediately be forwarded to the University failing which the candidature will not be considered.
