Nursing Entrance Test-2019 that the third round of Counseling for filling up the left out seats in the Private Nursing Colleges including Shimla Valley Nursing College, Sheetal Kunj Estate, Sanjauli has been fixed on 30.10.2019 at 11:00 AM in the H.P. University Auditorium. The candidates those called for 2<sup>nd</sup> round of counseling vide list dated 18.10.2019 which is already available on the University website ([www.hpuniv.ac.in](http://www.hpuniv.ac.in) & [www.admissions.hpushimla.in](http://www.admissions.hpushimla.in)) are hereby given an opportunity to attend the 3<sup>rd</sup> round of counseling for taking admissions in Private Nursing Colleges only on the above mentioned date, time and venue. The interested candidates are advised to attend the 3<sup>rd</sup> round of counseling alongwith required original certificates/documents. The candidates already admitted in Management Quota are also to be considered for State Quota seats in order of merit. Candidates those will attend counseling 1st time may bring with them a Counseling fee of Rs. 100/- in the shape of IPO/ Bank draft in favour of Finance Officer, HPU. The candidates who will be allotted seats in private nursing colleges are required to deposit an advance fee of Rs. 10,000/- during the counseling with the representative of the College management and the remaining fee & Other dues as per Govt. notification shall be deposited on the day of joining the colleges. In case, any candidate is unable to attend the counseling in person, she may depute an authorized person for attending the counseling, failing which her claim for admission shall be forfeited. No separate call letters will be issued for the said counseling.
