**NOTIFICATION**

The University is going to conduct the examinations of final year of the Under-Graduate classes w.e.f. 1<sup>st</sup> July, 2021 and the B.Ed. examinations w.e.f. 7<sup>th</sup> July, 2021. The heads of the institutions are to conduct the examinations by strictly following the Standard Operating Procedure as notified by the MHRD and adopted by the State Govt. and further adopted by the University.

In view of the COVID – 19 it has been decided to allow the candidates who may be stranded in their native place to appear in the examinations in nearby colleges where the papers of the particular streams are conducted. For which:

- (i) The students can appear in the college where the papers of the particular stream is available for which they should contact/consult the concerned college in advance.
- (ii) The students should intimate their parent college for change of examination centre and the particular college shall intimate the University as well as the college which has been opted by the student to appear for the examinations.
- (iii) For change of examination centre the eligible students are required to go to the University website and the students can change their examination centre for fresh and re-appear both out of the list of centres provided in the dropdown box. This facility is for one time only. Thereafter the fee for change of examination centre shall be charged as per University rules.

The Principals of the colleges shall allow such candidates to appear in their college and intimate the University accordingly.

**For smooth holding of the examinations the Principals should also constantly keep updated with the instructions issued by the University, from time to time which shall be uploaded on the University website.**
