**NOTIFICATION**

It is notified for the information of all concerned that for forthcoming examinations of Post-Graduate Degree and Diploma Courses w.e.f. 15<sup>th</sup> March, 2021 for which 44 examination centres throughout the State have been created. Out of the 52 Post-Graduate Degree and Diploma courses for which the examinations are being conducted the following degree and diploma courses are only campus based : **(1) Degree Courses** : M.A. Psychology, M.A. Drawing and Painting, MBE, MSW, M.A. Rural Development, MTA, MFA, MBA (RD), M.A. Journalism, M.A. in Defence and Strategic Studies, M.A. Yoga Studies, M.Sc. Env. Science, etc. **(2) Diploma Courses** : P.G. Diploma in Pahari Miniature, P.G. Diploma in Population Studies, P.G. Diploma in HRD, P.G. Diploma in Tribal Studies, P.G. Diploma in Women Dev. Studies, P.G. Diploma in Disaster Management, P.D. Diploma in Adult Education, P.G. Diploma in Guidance and Counselling. Besides these MBA and MMC are only in Shimla and Regional Centre Dharamshala and M.Sc. Geology in R.C. Dharamshala.

In view of the COVID – 19 situation, the students stranded in their native place are allowed, to take examinations at their nearby examination centres, except the above subjects which are campus based or which are being studied in HPU and R.C. Dharamshala only the students of other Post-Graduate courses can appear in nearby examination centres of their choice. For which the students after filling up their examination forms in their respective colleges, have been given an opportunity by the Computer Centre of the Examination Wing to

change their examination centre. This relaxation for change of centre for the first time shall be provided to the students without charging any fee and thereafter for the second time the charges shall be applicable as per the University rules.
