Therefore, he is eligible for hostel allotment/admission and has allotted hostel in SBS under ST Category.

Thereafter, the hostel fee **w.e.f. September, 2022 to June, 2023** for ten month(s) is also required to be deposited by them through online mode **w.e.f. 13<sup>th</sup> September, 2022 to 16<sup>th</sup> September, 2022** positively and copy of the fee deposited alongwith printout of their Hostel admission forms, relevant documents & one latest passport size photograph are to be submitted in the Chief Warden office latest by **17<sup>th</sup> September, 2022** failing which their admission in the Hostel shall stand cancelled.
