


A meeting of the Anti Ragging Committee was held in the office of the Dean of Studies at 2.30 PM on September 23, 2016. The following were present:


1. Prof. Girija Sharma, Dean of Studies.



The meeting ended with a vote of thanks to the Chair.






**Proceedings of the 3rd meeting of the Anti Ragging Committee.**





