

Proceedings of the meeting of committee, constituted to look into the matter with regard to identification of posts in the University which may be reserved for the persons with disabilities, held on 14<sup>th</sup> June, 2021 at 03:30 PM. in the Chamber of the Hon'ble Vice-Chancellor.

A meeting of the committee, constituted to look into the matter with regard to identification of posts in the University which may be reserved for the persons with disabilities, was held on 14<sup>th</sup> June, 2021 at 03:30 PM under the Chairmanship of Prof. Sikander Kumar, Vice-Chancellor, H.P. University in his Office Chamber.

The following were present:

1. Shri Suneel Sharma (HAS), Registrar, H.P. University, Shimla-171005. Member
2. Shri Bhupinder Chauhan, District Welfare Officer (Disabilities) Directorate of Empowerment of SCs, OBCs, Minorities and Specially Abled, H.P. Shimla-171009. Nominee  
(Nominee of the Director)
3. Shri Rajesh Sharma, District Employment Officer, Directorate of Labour & Employment, H.P. Nominee  
(Nominee of the Labour Commissioner-cum-Director)
4. Shri B.S. Jasrotia, Assistant Registrar (Admn.), H.P. University Member

At the very outset, the Chairman of the Committee, Prof. Sikander Kumar, Vice-Chancellor welcomed the members to meeting and thereafter, took up the Agenda Item for discussion and decision.

The committee considered the letter dated 23<sup>rd</sup> April, 2021 received from the Director, Empowerment of SCs, OBCs. And Minorities & the Specially Abled, H.P. Shimla-11009. The Chairman of the Committee was apprised that under section 34 of the Right of Persons with Disabilities Act, 2016, the provision for providing 4% reservation to Persons with Benchmark Disabilities in Govt. Jobs in every establishment, has been created by the Government. Before filling up the posts reserved for the Persons with Disabilities, the University establishment needs to identify the posts which can be held by the respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the section 34 of the Act. The Registrar informed the Committee that University has already identified 3% posts meant for the Persons with Disabilities by the Committee, already constituted for the said purpose on the instructions/ directions of the State Government received from time to time. The recommendation of the said committee was placed before the Executive Council vide Resolution No.16 of its meeting held on 31-07-2010 and the decision of the Executive Council, stood notified vide Notification No. 3-1/78-HPU (Genl.) Vol-XV dated 11-08-2010.

Now the State Government has extended 1% reservation to the Persons with Benchmark Disabilities in the direct recruitment vide letter No. PER (AP)-C-P(4)-I/ 2020 dated 22-06-2020 which had been adopted by the University vide Notification No.3-1/78-HPU (Genl.) Vol-XXII dated 24-08-2020 (Annexure-A).

The Committee after perusal of the instructions issued by the State Government from time to time, made the following recommendations:

- I. In compliance to provision under section 34 of the Right of Persons with Disabilities Act, 2016, the committee recommended as per Annexure - 'A' to update 4%


reservation in direct recruitment in the University in all posts to be reserved to the Persons with Benchmark Disabilities [in place of the reservation of 3%, allowed earlier to this category candidates by the University under section 32 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, vide Executive Council Resolution No.16 dated 31-07-2010], which already has been adopted by the University vide Notification No.3-1/78-HPU (Genl.) Vol-XXII dated 24th August, 2020 as per Annexure-A. The 'Quantum of Reservation', 'Exemption From Reservation' and other comprehensive instructions' clauses, are as per letter No.PER(AP)-C-F(4)-1/ 2020 dated 22<sup>nd</sup> June, 2020, issued by the Additional Chief Secretary (Personnel) to the Government of H.P., appended as Annexure-B.


II. As a requirement to section 33 (i) of the Right of the Persons with Benchmark Disabilities Act, 2016, the Committee has resolved that a Notification, showing the posts identified and quantum of reservation categoriwise for particular category of persons with disabilities, and exemption from reservation, be issued in accordance to the provision of this Act [letter No.PER (AP)-C-F (4)-1/2020 dated 22<sup>nd</sup> June, 2020].


III. The committee, in compliance to instructions [vide Sl. No.3, titled - 'Exemption From Reservation' of the letter No. PER (A)-C-F (4)-1/2020 dated 22<sup>nd</sup> June, 2020 from the Department of Personnel (AP-III)] resolved that exemption to the following post for providing 4% reservation under section 34 of the Right of Persons with Disabilities Act, 2016, be allowed in consultation with the State Commissioner (Disabilities) to the Government of H.P. on the grounds that the essential physical standard/ requirement/ capability cannot be relaxed because the nature of jobs of these posts :



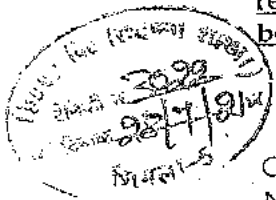

The Committee took up the Agenda Item for consideration and made the following recommendation:

- Item No.1** To place agenda item before the Committee constituted vide Notification No. 9-7/80-HPU (Genl.) dated 05.02.2021, for its consideration/ recommendations as may be deemed fit in the matter / representation of Shri Ram Chand, Junior Technician, Group - IV, Department of Bio-Technology for counting of contractual services rendered by him in IIHS.

The Committee perused the Agenda Item placed before the Executive Council in context of matter/representation of Sh. Ram Chand, for counting of contractual services rendered by him in the Institute of Integrated Himalayan Studies Center (now known as Department of Inter-Disciplinary Studies) w.e.f. 29.10.2002 to 27.12.2004 as Junior Professional Assistant, for reckoning pensionary benefits and annual increments on notional basis. The relevant record, including the representation (s) as well as his service record, were also perused by the Committee and after a deliberation on the matter it was observed by the Committee that Sh. Ram Chand was working as Laboratory Attendant in the University on regular basis in the pay-scale of Rs. 3120-5160. He applied for a contractual as well as dissimilar post of Junior Professional Assistant carrying fixed emoluments of Rs. 9500/- per month consciously. It was further observed by the Committee that pay-fixation, by granting Sh. Ram Chand, the benefit of notional annual increments, as desired/ requested by him, has already been attempted by the Establishment Branch in the year 2005 but the said proposal was not vetted/ passed by the Local Audit Department. As per subsequent clarification, received specifically in context of pay-fixation of


Sh. Ram Chand, it was advised by the Under Secretary (Higher Education), Department of Higher Education, Government of Himachal Pradesh, in consultation with the Finance-E Department, that lien on previous post cannot be retained in the case where a substantive employee is appointed to another post on contract basis. Accordingly, the Committee concluded and recommended that the request of Sh. Ram Chand for counting of contractual services rendered by him in IHS w.e.f. 29.10.2002 to 27.12.2004 as Junior Professional Assistant, for reckoning pensionary benefits and annual increments on notional basis is not tenable under the rules and cannot be acceded to.

At the very outset, the Chairman welcomed the member(s) of the committee. The instructions issued by the state Govt. and UGC regarding implementation of 200-point roster of reservation for direct recruitment of teaching posts in University and other relevant documents were placed before the committee by the convener. The recommendations of the committee constituted by the Hon'ble Vice-Chancellor and notified vide Notification No.3-1/78-HPU(Genl) Vol-XX dated 19.06.2019, of its meeting held on 06.09.2019 were also placed before the committee. The committee on 06.09.2019 had recommended that application of Reservation Roster is to be made applicable on all the posts of respective cadre of teacher i.e. Professor, Associate Professor, Assistant Professor. A copy of the recommendations of the committee dated 06.09.2019 is annexed as annexure "A".

The committee observed that the teaching cadre consist of Professor, Associate Professor and Assistant Professor only. Therefore, the committee recommended that the Research Staff i.e. Senior Research officer, Research officer and Project Officer working in the University constitute a different cadre and thus be excluded from the existing teaching cadres for the purpose of implementation of Model Roster of Reservation.

After detailed deliberations on the issue and consideration of the 200 point roster of Reservation placed before the Committee by the Deputy Registrar (Estt) presently act as Convener as discussed and directed by the Committee in its earlier meeting held on 27.09.2019 unanimously approved and made the following recommendations:-

1. The University had been implementing the 13 point Roster of Reservation Department/subject wise and Wing wise in the cadre of Assistant Professor only. Therefore, the committee unanimously resolved that the 13 point modal roster of reservation be replaced with 200 point roster. The existing Teaching posts be plotted / earmarked as per the 200 Model Roster of Reservation as circulated by the State Govt vide letter No. PER(AP)-C-B(12)-1/2019 dated 11.06.2019 and Office Memorandum No. PER(AP)-C-B(12)-3/2017 dated 22.06.2017 adopted by the University vide notification No.3-1/78-HPU(Genl) Vol.XX dated 19.06.2019 and notification No.3-1/78-HPU(Genl) Vol.XIII dated 16.10.2018 respectively; Annexure "B" and "C".
2. The 200 point roster be applied initially taking into consideration the alphabetical order of the existing departments / subjects of the University in respect of all teaching cadres and Research Staff as per instructions of the state Govt. adopted by the University vide Notification dated 16.10.2018 and 19.06.2019 referred above.
3. In the event of availability of new post / vacancies in future by way of creation of new department / posts, irrespective of notification of creation by the University and on cessation of services, for whatsoever reasons as the case may be, the new post/vacancy will be placed at the bottom of the existing sanctioned strength of the respective cadres as on the date of the approval of implementation of 200 point model Roster by the Executive Council;
4. Simultaneously in case more than one vacancies caused on superannuation of teachers on same date, the said vacancy shall be placed at the Bottom of the respective cadre and the person senior in age shall be give preference in the 200 point model roster of reservation. However, in case of same age & date of birth the length of service of teacher concerned shall be deciding criteria.



A discussion with the officers of the University under the Chairmanship of the Vice-Chancellor in his Chamber was held on 06-09-2019 at 11:30am. The following were present:

At the outset, the Vice-Chancellor spelt out the issues relating to implementation of model roster of reservation to the teaching cadre in the light of the provisions of the Central Educational Institutions (Reservation in Teachers Cadre) Ordinance, 2019 issued by the Ministry of Law and Justice dated 07-03-2019 and further circulated by the University Grants Commission. Besides this the instructions circulated vide notification No. 3-1/78-HPU(Gen.) Vol. XX dated 19-06-2019 wherein the model roster of reservation circulated by the Additional Chief Secretary(Personnel) to the Govt. of Himachal Pradesh vide letter No. PER(AP)-C-B(12)-1/2019 dated 11-06-2019 were also deliberated upon. In view of these instructions after thorough discussion, the following recommendations were made for consideration of the competent authority of the University:

1. It was unanimously decided that the model roster of reservation to the teaching cadre i.e. Professor, Associate Professor, Assistant Professors may be made applicable to the total sanctioned strength of the respective cadres on identical grade pay as per the Central Educational Institutions (Reservation in Teachers Cadre) Ordinance, 2019.
2. It was also decided that 200 point model roster of reservation may be made applicable on each teaching cadre and the sanctioned strength of the University as a whole.
3. It was further decided that in order to implement 200 point roster of reservation and to give fair representation to the earmarked categories, the department may be arranged in alphabetical order of english

10. The benefit of reservation for various post(s) will be admissible only to the candidates, who are Bonafide residents of Himachal Pradesh in respect of categories, viz. S.C., S.T., O.B.C., P.W.S., H.P.L., Ex-Servicemen, WFP and Persons with Benchmark Disabilities. The candidates are required to submit certificate in support of the claim of her/ his category as prescribed by the State Govt. from time to time.
11. Vol. XV dated 02.07.2021, a meeting of the Committee constituted vide Notification No.3-1/78-HPU(GENL) Vol.XXI dated 17.09.2019 was held on 05.07.2021 at 02:30 p.m. in the office of Dean of Studies, H.P. University, Shimla-5 to consider/examine the matter relating to de-reservation of vacancies reserved for earmarked categories under the 200 point Model Roster of Reservation for direct recruitment of teaching posts in the University. The following were present:-

At the very outset the Chairman welcomed the members of the Committee.


The instructions issued by the State Government vide Memorandum No. PER (AP-C-B(12)-3/2017 dated 22.6.2017, No. PER (AP-C-B(12)1/2019 dated 11.6.2019 and the University Grants Commission vide No. F-1-5/2006(SCT) dated 8.3.2019 regarding implementation of 200 point model roster of reservation for direct recruitment of teaching posts in the University, adopted by the University vide Notification No. 3-1/78-HPU(Genl.) Vol. XIII dated 16<sup>th</sup> October 2018, No. 3-1/78-HPU(Genl.) Vol. XX dated 19.6.2019 and adopted by the University vide Notification No. 3-20/88-HPU(Genl.) Vol. IV dated 12.12.2019 respectively were placed before the committee. The earlier recommendations of the said Committee of its meeting held on 6.9.2019 were also placed before the Committee. The instructions contained under Chapter 20 in the Handbook on Personnel Matters Vol-II of the State Government regarding reservations/de-reservation of posts to the earmarked categories and recent instructions issued by the State Government vide latest instructions and circulated vide letter No. PER (AP-C-B(12)1/2019 dated 18-3-2020 were also placed before the Committee. Besides, the detail of vacant posts, where no application/inadequate number of applications from the earmarked categories candidates, even in response to the repeated advertisements after advertisement vide No. advt. No. 17/19, 2020/2020 and 23/21 dated 30.12.2019, dated 17.8.2020 and dated 30.1.2021, were received by the University, was placed before the Committee for consideration.

After careful consideration of the above instructions, the vacancy position of teaching posts and all relevant record of the Committee, after detailed deliberations in the matter unanimously made the following recommendations:-

1. The Committee recommended that the vacant posts as earmarked for Persons with Benchmark Disabilities in the 200 points model roster of reservation in the cadre of Professor, Associate Professor and Assistant Professor may now be carried forward and earmarked to the next category of Persons with Benchmark Disabilities in Alphabetical order as has already been decided by the Committee of its meeting held on 6.12.2019 and 23.12.2019.
2. The Committee recommended that the vacant posts earmarked for Ex- Servicemen/wards of Freedom Fighters may be earmarked to the wards/dependents sons, daughters including married daughters and wives of Ex-servicemen/Freedom Fighters, as per prescribed percentage respectively, for the first recruitment year only and thereafter to the parent category as earmarked in the vertical order of 200 point model roster of reservation in the cadre of Professor, Associate Professor and Assistant Professor.
3. The Committee recommended that the vacant posts earmarked for Distinguished Sports Persons may be reserved to the respective parent category as earmarked in the vertical order of 200 point model roster of reservation in the cadre of Professor, Associate Professor and Assistant Professor.
4. The Committee recommended that when as Economically Weaker Section (EWS) candidate is not available for selection, the post will be treated automatically as de-reserved and will be filled up from a non-EWS candidate of unreserved category.
