The Committee visited the above institution on 04-07-2022 and directed the management of institute to put the relevant record before the committee. Thereafter on perusal of the record the committee observed following points:-

1. It was observed from the record submitted by the Management of the College that in total 68 (sixty eight) students in 5th semester of BHM course were admitted or on roll of the College whereas none of them were physically present at the time of visit of inspection committee. Similarly, the college has admitted 61 (sixty one) students in 6th semester of BHM but only eight students were physically available in the College Campus (Flag 'A'). The explanation given by College authority in this connection was not satisfactory.
2. Also, there seem to be quite anomalies in the fee charged by the college and the fee structure approved by the HPU Authority vide notification No. 1-533/2016-HPU (Acad.) dated 16.06.2022 (available on flag 'B'). The fee charged from the students was not approve by the University authority.
3. The Himachal Pradesh Private Educational Regulatory commission, who is the statutory regulatory body in H.P. to regulate private institutes, has also recommended to de-affiliate the said College and migrate the students to some other Colleges after the conduct of examination for that current session vide its order No. HPPERC/Case No. 29 of 2021-375 dated 08.04.2022. (Flag-C).

Therefore, keeping the above facts in mind the committee members are of the view that following the recommendation of the HPPERC the College be de-affiliated and students as suggested by the regulatory commission in the aforesaid order may be migrated other institute affiliated to H.P. University in which BHM course is running including Department of TVS of H.P. University, Shimla-5. The members of the Committee further decided that the recommendations of the Committee may be got approved from/by the Hon'ble Vice-Chancellor.

TECHNICAL SERVICES RULES OF COST OF CULTIVATION SCHEME,
HP UNIVERSITY, SHIMLA - 171 005 (HP)

Scope and Nature of Services:

All posts of Assistant Statistician, Field Supervisor & Field Assistant, the incumbents of which are performing data collection, supervision of field data, scrutiny and validation etc. constitute the Technical Services of the Cost of Cultivation Scheme, HP University, Shimla (CCS of HPU).

Date of coming into force the Service Rules:

The Technical Service Rules of the Cost of Cultivation Scheme, H.P. University, Shimla-5 will come into force from the date of notification of these rules upon approval of the recommendations of duly constituted Committee by the Executive Council of HP University.

Categories and grades of the services

The Technical Services are grouped into three categories consisting of following grades with scales of pay as adopted by the Indian Council of Agricultural Research on the basis of the recommendations of the VI Central Pay Commissions:

The model duties for above Technical posts of CCS of HPU are given as under:-

- i) **Field Assistant:** Collection of data in the field from sampled clusters.
- ii) **Field Supervisor:** To supervise data collection work of the field staff and ensure collection of quality data by providing on-spot guidance to the Field Assistants at their respective place of posting.
- iii) **Assistant Statistician:** Sample selection, Scrutiny, Compilation and validation of data at Head Office.

The model qualifications may kindly be seen from Table 3.

Initial adjustment of the existing employees:

The existing permanent employees appointed through Selections Committees / D.P.C. etc. will be fitted into respective grades (Pay Band & Grade Pay) according to length of service and qualification. The service and financial benefits/rights of the existing staff will be protected as such.

Career Advancement:

Career advancement of technical staff of CCS HPU in their respective categories will be done in the following manner:-

The entrants of category I at T-1 grade would continue to be regulated for assessment from T-1 to T-2 after five years of service in T-1. The T-2 grade personnel possessing the qualification graduation with one of the relevant subject i.e. Agricultural Economics/Statistics/Economics at the graduation level, would be eligible for assessment promotion to T-3 grade after five years of service, while those not possessing such qualification shall become eligible for assessment promotion to T-3 grade only after ten years of service in T-2 grade. The assessment promotions from T-3 to T-4 and T-4 to T-5 shall be at five years of intervals. The technical personnel in T-5 grade possessing essential qualifications prescribed in Table 3 i.e. Master Degree in Agricultural Economics/Statistics/Economics shall be eligible for assessment promotion to T-6 grade (Category-III) after completing five years of service in T-5 grade, while those not possessing such qualification shall become eligible for assessment promotion to T-6 grade after ten years of service in T-5 grade provided such technical personnel have the qualification graduation with one of the relevant subject as mentioned above. However, the technical personnel in T-5 grade who are not graduates shall not be eligible for further assessment promotion to category III of technical services.

The technical personnel in T-6 grade shall become eligible for assessment promotion to T-7-8 grade after completion of five years in T-6 grade. Those technical personnel's who are working in T-7-8 grade would be eligible for assessment to T-9 grade after completion of 7 years of service in T-7-8 grade.

The personnel working in T-4 to T-9 grade possessing the eligibility qualifications "Master Degree in Agricultural Economics/Statistics/Economics" only will be considered to promotion for the post of Field Supervisors. The senior most Field Supervisor possessing the eligibility qualifications "Master Degree in Agricultural Economics/Statistics/Economics" will be considered to promotion for the post of Assistant Statistician.

System of merit promotion

- There shall be a system of merit promotion from one grade to the next higher grade irrespective of occurrence of the vacancies in the higher grade or grant of advance increments in the same grade on the basis of assessment of performance. The persons concerned who get only one increment in the same grade in lieu of promotion will be eligible for consideration of promotion after the expiry of one year of service in the grade through Supplementary Information Document. The advance increment will be withdrawn when the concerned employee gets promoted to next higher grade. The assessment document will be required to be prepared by the concerned employee in the prescribed proforma: Appendix III. The supplementary information document may be prepared in the proforma as at Appendix III. A person who is not found fit for merit promotion will be considered every year till such time as he/she is adjudged suitable for promotion to the next grade.

- The following material is to be taken into consideration for assessment:
 - The material is furnished in the 5/7/10 yearly assessment proforma/ document.
 - APAR of the relevant period of 5/7/10 yearly assessment.
 - Performance record.

- The evaluation of APARs for the 5/7/10 yearly assessment period shall carry 80 marks as per grading given below and the remaining material shall carry 20 marks based on the assessment document:

i)	Each Outstanding APAR report	80 marks
ii)	Each very good APAR report	60 marks
iii)	Each Good APAR report	40 marks
iv)	Each Average APAR report	20 marks

Merit promotion from one grade to next higher grade shall be made only if an employee meets the following threshold (bench mark):

- The T-9 employee (Cat. III) shall be eligible for one increment after rendering 05 years of service in the position. This increment will be a part for pension and pensionary benefits.
- The APAR report in respect of CCS staff covered under this scheme shall be placed before the duly Constituted Committees.
- The position with regard to vigilance / non-vigilance case pending and/or being contemplated is required to be disclosed to the Assessment Committee.
- For determining the eligibility of person for the grade of merit promotion or advance increment (only one in the grade), the entire period of service in the grade including service rendered in the pre-revised scale of pay will be counted.
- The merit promotion or grant of advance increment in lieu of promotion to the successful personnel will be given with effect from the date following the date of completion of required service in the grade. The period of ad-hoc service in the same grade and also the period of authorized leave including study leave/EOL and period spent on deputation will also be counted. Period of EOL on private affairs, suspension treated as dies-non for all purposes, reduction to lower grade as a measure of penalty, will not be qualifying period for merit promotion.
- The assessment of eligible personnel for merit promotion/grant of advance increment in lieu of promotion for Cat. I & II will be done by the Departmental Promotional Committee to be constituted by the Appointing Authority (i.e. Hon'ble Vice-Chancellor of HP University). The Chairman of the Committee will be Director, CCS, H.P. University.
- For assessment promotion of Cat. III, the assessment will be done by the Assessment Committee to be constituted by the Hon'ble Vice-Chancellor of H.P. University.
- The vacancy in the event of retirement /death resignation of technical personnel carrying whatever personnel grade, through assessment promotion in the service shall occur only in the initial grade of his appointment under the service.

CATEGORY I

1. The following criteria will be adopted for the assessment of the technical personnel of CCS, HPU.
 - *Professional Performance in relation to the duties and task assigned.
 - *Spirit of cooperation and team work.
 - *Personal/behavioural abilities/attributes.
2. Emphasis in the assessment will be on the contributions of the individual in relation to requirements of the job and the duties assigned to the post for which he/she was recruited.

Procedure for Assessment

3. Assessment of the technical personnel shall take into consideration the following:
 - *The material furnished in the Assessment Proforma enclosed.
 - *CCRs for the last 5/10 years as the case may be.
4. The technical personnel being assessed shall carefully fill in the enclosed Proforma keeping in mind their activities in the past 5/10 years, as the case may be.
5. The reviewer shall be the immediate supervisor of the technical personnel concerned. In cases, where the reviewer has supervised the work of the reviewee for a very short period of time, say less than six months, he shall be required to consult other technical personnel who may have also supervised or worked with the reviewee for longer periods. Honorary Director will issue separate Orders indicating clearly the reviewer for each post.
6. After the Proforma have been completed by the Technical Personnel being assessed, that will be passed on to the Reviewee. The Reviewer shall then carefully go through the information provided by the Reviewer and the evaluation done by him/her and shall fill in items intended for him/her. Such a completed proforma will then be sent to the Accepting Authority Field Officer.
The Honorary Director shall then carefully look through the Proforma and in case notices marked discrepancies between the reviewer and reviewee's evaluation on the last item of Part II, he/she may give his/her comments on the discrepancies. In case he/she




