निर्णय: **The Executive Council in principally approved to implement the NEP at UG level from the Academic Session 2026-27 and to start two new courses i.e. B.Sc. Data Science and B.Sc. Artificial Intelligence and further decided that the matter may be taken up with the State Govt. for granting permission to start the NEP at UG Level and to start two new courses i.e. B.Sc. Data Science and B.Sc. Artificial Intelligence.**

मद संख्या-8: To place before the Executive Council recommendations of the Selection Committee meeting held on 11.11.2025 for promotion to the post of Associate Professor under Career Advancement Scheme in the subject of Business Administration (BBA) for consideration and approval.

निर्णय: **The recommendations of the Selection Committee, contained in a sealed envelope, were placed before the Executive Council. To consider the matter, the relevant record pertaining to Dr. Sanjeet Sharma, past services as an Assistant Professor, at UCBS, as required by the Executive Council alongwith Hon'ble High Court Order dated 26.09.2025 passed in Execution Petition No. 30 of 2025 titled as Dr. Sanjeet Sharma Vs. HP University & others was placed before the Council for perusal.**

The Council observed that Dr. Sanjeet Sharma joined HPU as an Assistant Professor on 28.12.2017. He had previously served in the Department of Higher Education (GoHP) from 11.06.2010 to 27.12.2017, on contract/regular basis at stage-1. After counting of past service, the teacher concerned was placed in stage-2, from 28.12.2017 (date of joining the University) & stage-3 w.e.f. 31.08.2019.

The Council noted that as per UGC Regulations, 2010, upward movement/ promotion from Stage-2 to Stage-3 is required to be granted strictly in accordance with the provisions as contained therein, which are reproduced as under:

6.4.6. Assistant Professors who have completed five years of service in the second grade (stage 2) shall be eligible, subject to meeting the API based PBAS requirements laid down by these Regulations, to move up to next higher grade (stage 3).

In view of the above, the matter was placed before the Screening-cum-Evaluation Committee in its meeting held on 23.09.2025 to re-examine/review the case regarding counting of the teacher's past service for upward movement from Stage-2 to Stage -3 in accordance with the above provisions. The committee recommended that the teacher concerned completed five years service in second grade (stage-2) by 28.12.2022 (if otherwise eligible), rather than 31.08.2019.

The council noted that since the candidate completed the requisite 5 years of service in stage -2 on 28.12.2022, as determine and recommended by the aforesaid Screening-cum-Evaluation committee, he is eligible for award of

upward movement to stage -3 w.e.f. 28.12.2022 (instead of 31.08.2019).

Considering the above facts, the Council did not accept the recommendations of the Selection Committee and referred the matter back to the Selection Committee and a afresh Screening cum Evaluation Committee to re-examine the case accordingly and determine the eligibility of his next promotion i.e. Associate Professor. The Special Secretary (Finance) pointed out that since CAS promotion is not allowed after Govt. Notification No. EDN-A-Kha (15)-3/2021 dated 01.08.2022. The case may be send to Finance Department through Administrative Department before issuing any order.

The Council further decided that a review petition be filed before the Hon'ble High Court of Himachal Pradesh against the orders dated 26.09.2025 passed in Executive Petition No. 30 of 2025 titled as Dr. Sanjeet Sharma vs HPU & Ors. to rectify the error as noted above.

Further the Executive Council perused the recommendations of the Academic Council vide item No. 10 of its meeting held on 05.12.2025 and decided that the matter may be re-examined.**

At the outset, the Dean of Studies greeted all members of the Committee and requested them to share their valuable suggestions on the various agenda items. Thereafter, the A R (Academics) presented the following agenda items for the Committee's consideration and decision-making:

Item No.1	What will be the nomenclature of the individuals engaged for academic activities at CDOE?
Decision	The committee reviewed the DEB and other relevant regulations, and recommended that the nomenclature for the eligible individuals involved in academic activities at CDOE be changed to Academic Counsellor.
Item No. 2	Procedure, Eligibility and the Remuneration of Academic Counsellor for PCP, Writing of Study materials, Evaluation of assignments, projects, etc..
Decision	The Committee recommends inviting applications from eligible candidates (as per UGC Regulations), for empanelment of Academic Counselors for PCP, writing study materials, and evaluating assignments and projects. All applications will be reviewed by a committee formed by the Hon'ble Vice Chancellor, who will recommend candidates for empanelment for one academic session, extendable yearly maximum for three years. The Remuneration for the PCP will be at par with the Guest Faculty norms of UGC adopted by H. P. University. The prerequisites and conditions for lesson writing will align with DEB guidelines. All lessons must be edited by editors of the CDOE. Retired teachers from universities or colleges and research scholars (without scholarship) who have completed a minimum of three years in a PhD program may be considered for the academic counselor. Additionally, working teachers, both within and outside HP University, may also be considered for writing study materials. The Director CDOE shall place the matter before EC/FC for approval. The teachers of CDOE and research scholars with fellowships will conduct PCP as part of their mandatory assignments.
Item No. 3	Revision of rates for Writing/Revision of lesson (CDOE) tying charges of lessons, refreshment etc.during PCP.

Decision	The committee reviewed the rates for writing and revising lessons (CDOE), which include charges for the lessons, refreshments etc. as specified in notification No. 18-21/2002/HPU/ICDEOL/Admn., dated July 24, 2009. Item No. 4	PCP in the event of thin presence of learners
Decision	CDOE shall conduct intensive PCP when there's a smaller number of attendees or for specific programs. For example if learners attendance is less than five, only three days PCP are to be provided, unless otherwise compulsory. Intensive PCP refers to specialized, focused academic or guidance sessions.
Item No. 5	Payment of pending bills of PCP
Decision	The Committee resolved that all pending bills to date (approval of proceedings) with regard to PCP of CDOE, may be processed as per existing norms. Since previous bills have been pending for a long time, hence should be processed on a priority basis.
Item No. 6	Regarding project report and comprehensive Viva-voce of M.Com & Other courses of CDOE students.
Decision	The Director of the Center for Distance and Online Education (CDOE) informed the committee about the challenges faced in supervising project work and conducting comprehensive Viva Voce examinations for approximately 1,700 students of Commerce subject. This issue has been exacerbated by the fact that candidates are now being admitted twice a year. After thorough discussions, the committee recommended that for Commerce and any other departments with "Project" components may be replaced with an equivalent course/ paper. The concerned BoS shall propose alternative course so as to resolve the issue. The Committee further resolved that all pending bills to date (approval of proceedings) with regard to "Project" of CDOE, may be processed as per existing norms.
Item No. 7	Should PCP be conducted Online/or Offline?
Decision	The committee opined that PCP may be conducted online/or offline, depending upon the operative guidelines of the DEB and UGC. In the event of an offline PCP on Sunday and Gazetted holidays, the concerned faculty teachers of CDOE/counselors will be entitled to remuneration of ₹ 1500 per day with local conveyance of ₹100 per day. The Director CDOE shall place the matter before EC/FC for approval.

- (e) In these subjects, the student shall be required to accumulate a certain minimum number of credits in order to qualify for the UG degree.
- (f) A student who has opted for a bachelor's degree will have the option available to him/her of converting the degree to a major (honours) degree. This will be done by accumulating 56 or more credits in one of the subjects chosen within a period of five years from the date of enrolment into the programme.

7.4: The following provision related to guidelines for the degree under CBCS shall be added:
For the Degree:

- (a) A regular candidate shall have to undergo the prescribed courses of study in a College affiliated to the H.P. University for a period not less than three academic years (and not more than five academic years), and should have passed the examinations prescribed and fulfill such conditions as have been prescribed thereof.
- (b) The Himachal candidates belonging to the SC and ST categories and women candidates from Himachal Pradesh shall be allowed to enroll with ICDEOL for the UG Programme by paying a fee of Rs. 500 as ICDEOL registration fee and a fee of Rs 500 for the hard copy course material. Such candidates shall be the students of ICDEOL for all purposes.
- (c) There shall be no private or other category of students and they shall be eligible for the degree either through regular mode or through distance education mode.
- (d) Candidates other than the regular candidates shall have to undergo the prescribed courses of study from the International Centre for Distance Education and Open Learning (ICDEOL) H.P. University for a period not less than three academic years (and not more than five academic years), passed the examinations prescribed and fulfilled such conditions as have been prescribed thereof.
- (e) For the degree (B.A. / B. Sc. / B.Com. /B.C.A. / B.B.A./B.E./B.P.E., Shastr) the student will have to cumulate a minimum of 120 successful credit hours of coursework for a bachelor's degree with major (honours), or 106 successful credit hours of coursework for a bachelor's degree over a minimum of three and a maximum of five years from the date of admission. (notified on 02.09.15 academic session 2013-14).
- (f) The candidate shall not be allowed more than three attempts to pass a course.

7.5: Duration (Time Frame)

✓

- (a) The UG (TDC) programme for a regular student shall be for a minimum period of three years and a maximum of five years from the date of admission of the candidate. Each academic year shall comprise two

semesters, viz. Odd and Even semesters. Odd Semesters shall be from June / July to October / November and the Even Semesters shall be from November / December to April / May. There shall be in each semester not less than 90 working days with 450 teaching clock hours (each working day having 6 teaching clock hours).

(b) The UG (TDC) programme for a distance education student shall be for a minimum period of three years from the date of admission of the candidate. However, there shall be no upper limit of the duration for completion of the programme.

7.6: Migration:(a)

- I. The Inter College Migration fee of Rs.500/- shall be charged from regular and ICDEOL students, who intend to migrate from a College.
- II. Migration fee of Rs.1000/- shall be charged from the students migrating from Colleges outside the State of Himachal Pradesh.
- III. Migration may be allowed only at the end of the 1st semester and before the beginning of 2nd Semester and so on, and no migration shall be allowed during the mid session.
- IV. No migration shall be allowed in the same station.
- V. No Objection Certificate/Character Certificate from the Principal of the parental College shall be mandatory, for obtaining migration. In case of students migrating from ICDEOL, the NOC /Character Certificate may be issued by the Director, ICDEOL. The University shall not involve itself for issuing letter to both the Principals and the mutual consent of the Principals is mandatory for migration.
- VI. Migration for Professional Courses of Under Graduate Classes may be allowed only where the mode of admission is the same as in other UG Courses.
- VII. In case, the Candidate seeks to get migration more than once, then the Controller of Examinations of Himachal Pradesh University shall determine the fee to be charged.
- VIII. The provisions of this Ordinance shall be applicable from the Academic Session 2013-14.

(b) Inter-institutional migration (including from one college to another as well as from a college to the ICDEOL and vice-versa) of students shall be allowed only when no-objection is obtained from both the relieving and the receiving institutions (signed by their respective principals/directors) to ascertain especially that the major/minor subjects being studied by the migrating student are available in the receiving institution. In such cases the credits and grades earned by the student at the relieving institution shall be carried by him/her to the relieving institution (details will be provided by the relieving institution while furnishing no-objection for such migration) and will be added to the credits and grades that the student will be earning at the receiving institution. All the conditions and requirements for the degree including the time frame will remain as given above and in other clauses of the regulations. (Notified on 02.09.15, academic session 2013-14).



- (3) The workload of a teacher shall take into account teaching, research and extension activities, preparation of lessons, evaluation of assignments, term papers etc. shall be in accordance with the guidelines issued by the Commission:

Provided that the time spent on extension work where it forms an integral part of the course specified shall count towards the teaching load.


- (4) The number of full-time dedicated teachers exclusively for Open and Distance Learning Mode and/or Online mode and other administrative and technical staff shall be appointed as stipulated under Annexure-IV of these regulations.
- (5) The details of the faculty in the Schools of Studies or Centre for Online Education or Centre of Distance and Online Education of the Higher Educational Institution and in the Learner Support Centres (for Open and Distance Learning Mode only) shall be declared on the website of the Higher Educational Institution and be linked to Aadhaar details or other Government identifiers.
12. **Use of e-resources for Open and Distance Learning mode.**— (1) A Higher Educational Institution offering programme(s) in Open and Distance Learning mode shall take such measures as are necessary to blend Information Communication Technologies (ICT) including those developed by National Mission on Education through Information and Communication Technology, for enhancing effectiveness of teaching – learning process, and administrative functioning and for maintenance of updated information at all times in respect of status of admissions, registration, for managing teaching-learning activities through online support for interactive learning with learner feedback, to facilitate the use of Open Educational Resources (OER), Massive Open Online Courses and for continuous as well as comprehensive evaluation, certification, and other aspects of learner support.

- (2) A Higher Educational Institution may allow up to forty per cent. of the total courses being offered in a particular programme in a semester through the Online Learning courses/ Massive Open Online Courses.

// 13. **Programme Launching Process for Higher Educational Institution.**—

(A) **Common Provisions for Open and Distance Learning Mode and Online Mode:**

- (1) The proposed programmes shall be designed for conventional learners, as well as for working professionals and other individuals aspiring to acquire knowledge and associated academic credentials through Open and Distance Learning Mode and/or Online mode.
- (2) **Minimum and Maximum Duration of Programme:**
- (i) The minimum duration for completion and award of degrees at the undergraduate and postgraduate levels in Open and Distance Learning mode and Online mode shall be in accordance with the UGC notification of specification of degrees, 2014;
- (ii) The minimum duration for completion and award of post graduate diploma shall be two years;

To place before the Academic Council or the Standing Committee of Academic Council the matter regarding the approval for repatriation of one post of Assistant Professor (UR) along with the reservation roster, which was earlier transferred from the Department of Lifelong Learning to the Department of Environmental Sciences, and to further approve the advertisement of the said post in the Department of Lifelong Learning for the subject of Rural Development.

Explanatory Note:

The post of Assistant Professor (UR) was transferred, along with the reservation roster, from the Department of Lifelong Learning to the Department of Environmental Sciences vide Notification No. 9-6/2020-HPU(Gen)Vol. dated 22.02.2022. It is pertinent to mention that the transfer of above said vacant post was made without any recommendation or consent of the Departmental Council of Lifelong Learning department.

Since the transfer of above post, the scholars and students of the Rural Development programme have been consistently demanding repatriation of the said post, as the transfer adversely impacted the academic and career prospects of the students as well as the department. The Department of Lifelong Learning has repeatedly taken up the matter with the authorities, and finally, the Hon'ble Vice-Chancellor has approved the repatriation and advertisement of the said post in Rural Development.

Further, the Department of Environmental Sciences has also conveyed its consent and recorded its no objection remarks (NOC) regarding the repatriation of the said post to its parent department.

It may be noted that the Department of Lifelong Learning is currently offering M.A. in Rural Development and Ph.D. in Sustainable Rural Development programmes. At present, the department has only one regular faculty member, supported by two guest faculty members.

It may be noted that the Department of Lifelong Learning is currently offering M.A. in Rural Development (MARD) and Ph.D. in Sustainable Rural Development programmes. The MARD programme has an annual intake of 40 students (35 subsidised seats + 05 non-subsidised seats), and since its inception, about 12 batches of MARD have successfully passed out from the department. In addition, about 03 batches of M.Phil. Rural Development students have also passed out, and currently, there is a batch of 04 Ph.D. research scholars pursuing research in the department.


At present, the department has only one (01) regular faculty member, supported by two guest faculty members. Due to the shortage of faculty, the smooth functioning of the MARD programme is being adversely affected, and further Ph.D. admissions and research are being held up. It may also be noted that, at the time of engaging the later guest faculty, the department had clearly emphasized that the appointment be made specifically from the Rural Development subject, and accordingly, one post was advertised specifically for the Rural Development subject only.

In view of the above, the repatriation and subsequent advertisement of the said post in the Rural Development subject is crucial for strengthening the department's teaching and research activities.

Points for the Consideration:

1. The post of Assistant Professor (UR) was transferred directly on the recommendations of the Standing Committee of Academic Council without any consent of the Departmental Council. Accordingly, its repatriation also requires the recommendation of the Academic Council/Standing Committee of Academic Council, being the same authority through which the transfer was effected.
2. The Department of Environmental Sciences has already provided its consent and **No Objection (NOC)** remarks in favour of the repatriation of the above said post along with its reservation roster.
3. The Department of Lifelong Learning urgently requires the said post to cater to its academic programmes i.e. **M.A. in Rural Development and Ph.D. in Sustainable Rural Development**, given the acute shortage of regular faculty.
4. The MARD programme has the annual intake of 40 students and has produced 12 batches of postgraduates and 03 batches of M.Phil students so far. Additionally, at present 04 scholars are pursuing their Ph.D research from the department. But due to the availability of only a single regular teacher, the teaching of MARD as well as Ph.D. admissions and research, are being severely affected in the department of Lifelong Learning.
5. Approval of the Academic Council/Standing Committee of Academic Council is therefore solicited for the repatriation of the above said post of Assistant Professor (UR) along with its reservation roster to the Department of Lifelong Learning and advertisement of the said post in the subject of Rural Development.





(Explanatory Note: It is submitted before the Executive Council that Sh. Suresh Kumar Verma, Member, Executive Council vide his representation dated 22-12-2025 addressed to the Hon'ble Vice-Chancellor has requested to place the matter before the Executive Council regarding amendment in the Statutes 22(5) & Ordinance 35.52-A. A copy of the representation is annexed herewith as Annexure-A. In the said representation, it has been stated that the Appointing/Disciplinary Authorities in respect of Category A, B, C & D have been defined under Ordinance 35.7 of the First Ordinances of the University and as per Statutes 22(5) and Ordinance 35.52-A, the Appellate Authority has been defined only in respect of Category A & B employees whose appointing authority is Executive Council whereas the Appellate Authorities in respect of Category C & D employees has not been clearly defined whose appointing authority is Vice-Chancellor/ Registrar. The copies of the Statutes 22(5) and Ordinance 35.7 & 35.52-A are annexed herewith as Annexure B & C. Therefore, he has requested to place the matter of amendment in Statutes 22(5) and Ordinance 35.52-A before the Executive Council.

PROCEEDING OF THE MEETING HELD ON 17.12.2025 WITH REGARD TO EXAMINE AND PROPOSE THE REVISION OF FEE IN RESPECT OF UNDERGRADUATE, POSTGRADUATE COURSES OFFERED THROUGH CENTRE FOR DISTANCE AND ONLINE EDUCATION WITH EFFECT FROM JANUARY 2026 SESSION.

A meeting of the committee constituted by the Hon'ble Vice-Chancellor was held on 17.12.2025 at 3:30 p.m. in the office of the Dean of Studies, H.P. University under the Chairmanship of Dean of Studies, H.P. University to examine and propose revision of fee in respect of Undergraduate, postgraduate courses with effect from the upcoming Academic Session and onwards. The following were present:-

At the outset, the Dean of Studies greeted all members of the Committee and requested them to share their valuable views/suggestions/opinions on the agenda: Revision of fees for Undergraduate and Postgraduate Courses of CDOE from the January 2026 session onwards. The D R (Admin.) CDOE presented the point-wise background and overview of the agenda as follow:

1. The fee structure for Undergraduate courses (B.A./B.Com.) and Postgraduate courses (M.A., M.Com., MBA, M.A. Education, and M.A. JMC) was last revised with the approval of the Statutory Bodies, including the Executive Council, during the Academic Session 2019-20. The candidates are now admitted to various courses biannually in accordance with UGC-DEB guidelines, which has substantially increased the number of students in the CDOE/ICDEOL.
2. The Personal Contact Programme (PCP) is a crucial academic component aimed at providing guidance and support related to courses for learners. To support this initiative, six Learner Support Centres have been established at various government colleges and institutes for the Centre for Distance Online Education (CDOE). The CDOE incurs significant expenses related to PCP activities, including organizing PCP for both undergraduate and postgraduate courses, as well as covering costs for postage, stationery, and the printing of study materials. Additionally, the remuneration for academic counselors and resource persons has been increased from Rs. 1,000 to Rs. 1,500 per lecture, in accordance with UGC norms adopted by Himachal Pradesh University.

- i. The committee, after a detailed discussion on the points underlined above, compared the fee structures of HPU's CDOE with those of neighbouring universities' CDOE and noted that the fees charged by HPU CDOE are significantly lower. The existing fees structure poses challenges for CDOE in covering increasing academic and administrative expenses. A comparative chart has been included as Annexure "A" for reference.
- ii. Additionally, the UGC-DEB (2020) has standardized mandatory credit values for Self-Learning Materials (SLMs). This has significantly increased the costs associated with the preparation, printing, and distribution of SLMs to learners enrolled in various undergraduate and postgraduate courses under CDOE.

Decision

The Committee unanimously agreed to revise and enhance the fee structure, taking into account all relevant aspects for all CDOE courses, for better support for learners in meeting academic and quality requirements. The committee recommended the revised fee structure, as detailed in the Annexure B, which will apply to students enrolled in HPU's CDOE starting from the January 2026 session. Additionally, the Committee proposed that the fee structure for CDOE courses be increased by five percent every three years. Accordingly, Classification of revised fee structure has been prepared at Annexure C.

Regarding the fee structure applicable to Himachali candidates belonging to the SC/ST categories and women candidates of Himachal Pradesh, it will be revised as per the instructions of the HP Government. The communication in this regard has already been sent to the quarter concerned. However, if HPU doesn't receive a reply within two months, HPU CDOE shall revise the fees for them as well, in proportion to the other courses.
