OFFICE MEMORANDUM

Subject: Payment of arrears to pre-2016 pensioners/family pensioners (70 years and above) on account of revision of pension/family pension w.e.f. 01.01.2016.

1. In continuation to this Department's Office Memorandum No. Fin(Pen)A(3)-1/2021-Part-II-Loose dated 17.09.2022, the Office Memoranda No. Fin(Pen)A(3)-1/2021-Part-II dated 13.03.2024 and 19.06.2025 on the subject cited above, the undersigned is directed to say that the Governor, Himachal Pradesh is pleased to decide that the remaining 30% of total pension/family pension arrears to the Government pensioners and family pensioners who have attained the age of 70 years and above will be paid with the pension/family pension for the month of January 2026.

2. Now, the cumulative released arrears of pension/family pension, after taking into account the present release, shall be 100% of the total arrears. Hence, the balance pension/family pension arrears in respect of this category of pensioners and family pensioners will be NIL.

3. All the Pension Disbursing Authorities (PDA) including Banks will ensure that any extra amount of pension/family pension, if recoverable, shall be adjusted from the arrears of pension/family pension being paid to them and only the balance amount is released.

4. It shall be responsibility of the Pension Disbursing Authorities including Public Sector Banks, that arrears as detailed in para-1 above, are drawn and disbursed to the pensioners and family pensioners who have attained the age of 70 years and above with the pension/family pension for the month of January 2026.


