ORDER/APPEAL

Whereas, the second wave of Covid-19 Pandemic has taken place in the country and is very fast spreading and fatal. Despite several social welfare measures undertaken by the State Government during the pandemic, hardships might still be faced by the citizens, particularly the poor and marginalized sections of the society. It is therefore felt that concerted and co-ordinate efforts on part of the State Government, Civil Society and all citizens are required to strengthen the health care infrastructure in the State in this hour of need for which funds are required.


Now therefore, it is hereby directed that all the Drawing and Disbursing Officers in various Departments/Public Sector Undertakings/ Autonomous Bodies under the Government of Himachal Pradesh shall deduct two days' salary/emoluments of each Class-I & II employee except health care workers working on regular/contract basis from whom one day salary shall be deducted. They shall deduct one day salary from all Class-III & IV employees working on regular/contract basis. The collection shall be deposited in the "HP Covid-19 Solidarity Response Fund" with details as under:-
