

3. Candidates(s) who are admitted under fellowship scheme/ PWD / Ward of HPU employee has to submit **"Affidavit of Non-Working" and undertaking duly signed by the candidate.**
4. The candidate's who are admitted under **in service teacher category** has to submit **NOC and Leave certificate for six months course work** and have to **ensure 12 months' residency in HP University campus**. These candidates if reported / found leaving their jobs after admission in Ph.D. at any stage during the Ph.D. program, the Standing Committee has the right to cancel their admission.
5. Candidates(s) who have passed their qualifying examination from a University other than H P University are required to submit migration certificate to the office of HPUBS.
6. In case of any misrepresentation of facts or any discrepancy is found later, his/her admission is liable to be cancelled without any prior notice.
7. The candidates are advised to ensure to submit all the necessary documents specifically mentioned at **Sr. No. 03 and 04** before deposits the PhD enrolment fees.
8. The Academic Committee and Standing Committee of HPUBS reserves the right to cancel the admission of a candidate if any discrepancy is found at any stage.
