## NOTICE FOR OPEN AUCTION

The following term and conditions were recommended by the committee members:

- i. The material shall be given to Authorized/ Govt. approved vender only.
- ii. The EMD of Rs. 10,000 (Ten Thousand Only) in the shape of the Demand Draft in favour of *Finance Officer, H.P.U. Shimla* should be deposited at the time of auction. The EMD amount will be refunded to vender after receiving the certificate / manifest of complete material lifted from the Department.
- iii. The final auction amount has to be deposited by the vender in the form of Demand Draft, before release of final order/ lifting the material.
- iv. The transport and loading charges shall be borne by vender itself which shall not be included in the auction value.
- v. Site clearance Certificate should be submitted by the vendor on the day of lifting / shifting of items.
- vi. Only the items mentioned in the list prepared by office of Department of Computer Science shall be lifted by vender.
- vii. E- waste certificate is mandatory for computer and Electronics items.
- viii. Site should be cleared within a week after auction.
- ix. 25% of the final bid amount shall be deposited by the vendor on spot in the shape of Demand Draft in favour of *Finance Officer*, *H.P.U. Shimla.*
