I.	Retainership Fee to be Paid.	= Rs. 9000/- Per Month
II.	Fee for contesting cases instituted against the University till the finalization of the case in the court of Law.	= Rs. 6000/-Per case
III.	Fee for initiating cases by the University till the finalization of the case in the court of Law.	= Rs. 7000/- Per Case
IV.	Expenses on account of purchase of stamp papers, judicial papers and stamps, attestation charges for affidavit charges, etc., fee paid for obtaining copies of Court /Orders/ Judgement will be refunded to him.	
V.	Clerkage at the rate of 10% of fee fixed for contesting cases will be paid.
