- 2. No payments on account of revised pay arrears may be made to Government employees who have opted their fixation of revised pay by way of minimum enhancement of 15% under the Finance Department's instructions No. Fin(PR)-B(7)-1/2021-loose dated: 10<sup>th</sup> February, 2022.
- 3. The amount of Interim Relief already paid vide this Department's Office Memoranda whose detail is given below (also refer Note-5 below Rule-7 of the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022, is required to be adjusted against the release of pay arrears:-

In case of State Government employees, who have worked in different Government Departments or PSUs/Boards/ Corporations of the State Government etc., w.e.f. 01.01.2016 to 31.12.2021, the arrears may be prepared and disbursed by the concerned State Government Department or PSU/Board/ Corporation etc. where such employees are presently working.
- 6. These orders shall also apply to the Government employees whose pay is regulated under the UGC pay structure.
