Mode of recruitment thereof.

Sir,

It is reiterated that no new post is created or no vacant post is filled up through direct recruitment by any mode in any Government Department/Organization except with the prior concurrence of Finance Department and subsequently, approval of Council of Minister(s).

2. This is to bring to your notice that various post(s) are filled up by a mode of recruitment approved by the Government. As per normal practice adopted by the Government, all the Class-III post(s) are filled up on contract basis except the post(s) of Driver(s) which are filled up on daily wage basis only. While all the Class-IV post(s) are filled up on daily wage basis only. Subsequently, these daily wagers/contractual person(s) are regularized as per policy of the Government.

3. I'm, therefore, directed to request you to ensure that no post of Class-III or Class-IV employees in the Department(s)/ Boards/Corporations/Public Sector Undertakings/Autonomous Bodies etc. in Himachal Pradesh, working under your control is filled up by a method other than the mode of recruitment as defined in Para-2 above.
