Inclusion of following points for the M.PEd. course in the PG Regulation-2022 under CBCS.

Sir/Madam

In continuation to this office letter of even No. dated 01-12-2022 on the subject cited above, the Executive Council vide additional supplementary item No. 16 of its meeting held on 06-04-2023 has accorded its approval to the recommendations/decision taken by the Standing Committee of Academic Council vide item No. 2 of its meeting held on 22-03-2023 to include the following points in the PG- Regulation 2022 under CBCS at page No. 12 in respect M.PEd. course as under:-

- 1. The courses in each Programme shall be either of **04 credits or 06 credits each** (Except Law, Music and Sciences). Moreover, an exemption in this context shall be as per NCTE for the Department of Physical Education because the recognising body is giving maximum of **03 credits** for each course.
- 2. That GE courses shall be implemented in 2nd and 4th semesters and shall have four credits each. Moreover, it is important to mention in this context that Department of Physical Education is offering school internship in 4th semester and it would be difficult for the students to opt the courses of unrelated disciplines/subjects in offline mode. Hence, an exemption in this context shall be for the students of Department of Physical Education to opt the GE Courses from online E-Learning Platforms e.g., Swayam and other massive open online courses.
- 3. As per the table given at page no. 12, there are some Mandatory Non-CGPA (Compulsory and Elective courses) but the Department of Physical Education is offering Skill Enhancement Course (SEC) in all the semesters, which is compulsory and having credits as per NCTE

Guidelines. However, Departemnt of Physical Education is offering AEC courses which are non-CGPA. Therefore, the Department of Physical Education shall be exempted for the inclusion of CGPA based Skill Enhancement Courses (SEC) in the PG Regulations-2022 under CBCS.
