The Above mentioned admitted candidates are directed to deposit their Ph.D. registration fee of Rs. 5000/- (five thousand only) through online link miscfee.hpumla.in latest by 14.6.2023 positively (and submit the fee challan copy in the department) failing which his/her admission to Ph.D. Programme will be cancelled.


Note:


1. In case any discrepancy/misrepresentation of facts is found at later stage. The admission of such candidate will be cancelled.

2. The candidates who have not submitted their consolidated marks card at the time of counseling are directed to submit the same within three days from the date of counseling.
3. The candidates who have passed their qualifying examination from outside H.P. University are directed to submit their migration certificate within one month from the date of admission.
4. The candidate who is in service/employed will be required to produce NOC to Standing Committee for approval of his/her registration to the Ph.D. Programme.
5. There shall be a minimum residency requirement of twenty months over the entire duration of the Ph.D. programme to be certified by the supervisor and the chairperson. This shall be in addition to the six month period of course work required for those candidates who have not done their course work at the M.Phil level. Hence the candidate who are admitted directly after M.A./ M.Sc. or equivalent degree to the Ph.D. Programme shall have to complete course work in the first semester. They shall attend regular classes for one semester and are required to pass all courses of that semester.
6. The candidates who are admitted in M.Phil currently and have not submitted their dissertations at the time of enrolment, in case these candidates are enrolled for Ph.D. Programme their admission in M.Phil shall automatically stand cancelled.
7. The admitted candidates are also advised to give the affidavit that they are not in any govt. service.
