1. Each quotations should be accompanied with an security money of Rs. 3000/- (Three Thousand Only) in the shape of Bank Draft drawn in favour of Director, ICDEOL, H.P. University, Shimla-5. The security money will be refunded after lifting of the stock against full payment in terms of the accepted rates of the quotation. Any quotation which is received after the stipulated date shall not be accepted. Postal delay will not be a excuse for no-receipt of the quotation on due date. No conditional quotation will be entertained.
2. GST will be charged @ 5% extra.
3. The cost of the material will be have to be deposited in the account of the Director, ICDEOL before lifting the material. Sale tax, if any payable will be paid by the Contractor.
4. The entire material has to be lifted within 15 days from the acceptance of the rates of quotation failing which the security money shall be stand forfeited and no correspondence will be entertained thereof.
