CIRCULAR

In view of the above, it is requested and emphasized to ensure submission of parawise comments/ replies and meticulous compliance with the judgments/ direction of the Hon'ble Courts **PERSONALLY** without any delay. In the event of delay or departure in such matters, the concerned Officers/Branch In-charges/HODs/Chairpersons/Principal will be held personally liable for such lapse(s) and responsibility of the erring official shall be fixed.

It may also be ensured that replies/Parawise comments required to be filed before the court(s) are brought on file with explicit description/complete details on noting's forthwith.
