

Further, the provisionally admitted candidates are also hereby advised to deposit enrolment/Registration forms along with relevant documents matric onwards duly filled by 20.06.2024 till 02:00 P.M positively in the office of the undersigned so as to consider their cases in the Standing Committee meeting for Registration in Ph.D programme.

The above candidates are informed to submit an undertaking clearly stating the following:


- That he/she will neither do any job nor go for any job during the entire tenure of the course.
