OFFICE MEMORANDUM

Subject: Dearness Allowance rates for NPS Subscription.

Whereas, it was observed by the Government of Himachal Pradesh that employees who were still subscribing to NPS regime were suffering a loss with respect to their future Pensionary benefits due to the differential of Dearness Allowance rates of Central Government with that of the State Government. Hence it has been decided that for all NPS subscribing employees the Dearness Allowance would be admissible at the Government of India rates from the applicable dates and as amended from time to time.

2. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.


