OFFICE MEMORANDUM

Grant of Dearness Relief to Himachal Pradesh Government Subject: -Pensioners/ Family Pensioners.

- In continuation of this department's O.M. No. Fin (Pen)B(10)-1. 6/98-IV-Loose dated 19th October, 2024, the undersigned is directed to say that the Governor, Himachal Pradesh is pleased to decide that dearness relief @ 3% will be paid to the Government pensioners/family pensioners including AIS pensioners/family pensioners w.e.f. 01.07.2023. Accordingly, existing rate of dearness relief will enhance from 42% to 45% after this decision.
- The additional Dearness Relief shall be paid with the 2. pension/family pension for the month of October, 2025, payable in the month of November, 2025. The arrears of dearness relief @ 3% w.e.f. 01.04.2025 to 30.09.2025 shall be credited in Bank Account of the pensioners in the month of October, 2025. The decision on payment of arrears of dearness relief for the period 01.07.2023 to 31.03.2025 will be taken separately in due course of time.
- Payment of Dearness relief involving a fraction of a rupee shall 3. be rounded off to the next higher rupee.
- Other provisions governing grant of dearness relief to pensioners, 4. regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.

As dearness relief will be at a uniform rate, it has been decided to 5. dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority

(PDA), including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.

Principal Accountant General, (A&E) H.P., Treasury The 6. Officers and authorized Public Sector Banks are requested to arrange the payment of Dearness Relief to pensioners on the basis of these orders, immediately.
