However, despite repeated correspondence and telephone calls, your college has not yet deposited the annual sports entry fee at the office of the 'Directorate of Physical Education and Youth Programmes.

Therefore, you are once again requested to kindly remit the annual sports entry fee amount through Bank Draft /RTGS/NEFT along with the enclosed student's strength certificate dully attested by the Principal/ Head of the Institution in favour of **SECRETARY SPORTS & CO-CURRICULAR ACTIVITIES COUNCIL, H.P. UNIVERSITY, SHIMLA-5** for the session 2025-26 within a period of 07 days from the receipt of this letter failing, which the matter will be presented before the Executive Board of the HPUS CSC for further action, in order to determine whether or not your college should be permitted to participate in the Inter-College Championships from the session the 2026-27.
