Note: As per directions received from the competent authority, due to adverse weather conditions/road blockade or any other similar conditions, the students may be permitted to participate in counselling process through online mode so that genuine students are not be debarred from the counselling process.

Please note that : The Documents in original & a set of self attested photocopies placed properly in a sequential order to be produced before the committee during counselling are as under:

- (i) Printout of ONLINE application form, Original documents & self attested photocopies of Matriculation, 10+2, B.Sc (all semesters or consolidated marks sheet), Category certificate (if applicable), H.P Bonafide/Domicile certificate, latest character certificate issued by the last institute attended by the candidate (however, If a student has a gap after his/her Graduation/studies, he/ she has to submit the character certificate issued by the Tehsildar of the concerned region), Person with disability (PWD) certificate (if applicable), EWS certificate (if applicable), Single Girl Child Certificate from the competent authority clearly mentioning that she is the only child & Girl Child of her parents (if applicable), Ward of HPU employee certificate (if applicable), J & K migrants certificate (if applicable), Sports/Cultural certificates (if applicable).
- (ii) Further, students who have passed their B.Sc from University other than H.P. University Shimla are required to bring CGPA conversion formula into Percentage certificate from their respective Institute(s).
- (iii) The eligible candidates who have applied under Sports/Cultural category are also required to attend the counselling for verification of academic & other relevant documents. However, Sports trials of the candidates will be conducted by the Directorate of Physical Education & Youth Programme H.P. University and & Cultural trials will be conducted by the Dean Students Welfare H.P. University, Shimla. The dates of Sports/Cultural trials may be confirmed from the concerned Offices/ Departments & dates will be notified by them in due course of time.

** Those candidates who could not attend the counselling on 6th & 7th July, 2026 under Non-Subsidized seat only may attend the counselling on 18th July, 2026 and notice in this regard will be issued separately.*
