6. **BID OPENING DETAILS:-** The technical bids shall be opened on **18.02.2026** at **11:30 Hrs** in the office of Executive Engineer (Maint.), Division No.- II (Maint.) H.P. 7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.

 - iii) Bidders must having G.S.T. No. and PAN No. The bidders has to produces/attach the copy of Registration, Tax clearance certificate, EPF No., ESI No. and list of equipment/machinery. ***(Without above document bid may be rejected)**
 - iv) **No extension will be allowed except in extra ordinary circumstances and work should be completed in the stipulated period.**
