THE HIMACHAL PRADESH UNIVERSITY ACT, 1970
(ACT NO. 17 OF 1970)

**AN
ACT**

to establish and incorporate a University in Himachal Pradesh.
BE it enacted by the Legislative Assembly of Himachal Pradesh
in the Twenty-first year of the Republic of India as follows:-

1. Short title and commencement:-

- (1) This Act may be called the Himachal Pradesh University Act, 1970.
- (2) It shall come into force on such date as the State Government by notification in the Rajpatra, Himachal Pradesh, appoint.

The Act published in the Rajpatra dated the 28th July, 1970 vide notification No. 6-10/70-LR dated the 22nd July, 1970.

The Principal Act further amended from time to time as under:-


- i) The University shall offer only those programmes through open and distance mode which are approved by the statutory bodies of the University as per norms and also by UGC and wherever necessary by the Apex regulatory bodies of the country.
- ii) It is the responsibility of the University to follow the norms prescribed by the concerned regulatory body/ies such as UGC/AICTE/NCTE, or any other and also seek its/their prior approval, wherever required, before offering any specific programme through distance mode.
- iii) The University shall not start any new programme without prior approval of UGC and other concerned regulatory authorities in anticipation of recognition.
- iv) The Nomenclature of all programmes shall be as per UGC/AICTE Regulations.
- v) No teacher education programmes shall be offered without prior approval of the NCTE.
- vi) The MHRD directions prohibiting B.E./B.Tech through Distance mode vide its letter dated 29.7.2009 shall be adhered to strictly (copy at UGC website).
- vii) Programmes in Engineering and Technology i.e. BE/B.Tech/Diploma courses in Medicine/Nursing/Physiotherapy etc. are not allowed through distance mode and University shall not offer the same.
- viii) The University shall refrain from offering such programmes that are not allowed to be offered through distance mode by respective Apex body/ies.
- ix) No on line programme leading to award of degree/certificate shall be offered by the Institute until a policy is framed and approved by UGC in this regard.
- x) The minimum duration of a programme offered through ODL mode should not be less than the minimum duration of similar programme offered through the regular mode.
- xi) The University shall run its Open and Distance Learning programmes in those subject/fields which are offered by it through regular mode only.
- xii) The University should have at least one full time faculty member exclusively for coordinating each programme at the headquarters.
- xiii) The eligibility conditions for admissions shall be as per norms of UGC/AICTE and other regulatory bodies.
- xiv) The territorial jurisdiction in respect of University for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC notification No.F.27-1/2012 (CPP-II), dated 27th June, 2013, a copy of which is also posted in the UGC website www.ugc.ac.in/deb.
- xv) In respect of standalone Institutions (other than the Universities), the territorial jurisdiction will be headquarters.


The following was deliberated upon and the decisions were taken accordingly:

REVISED M. PHIL COURSES AS APPROVED ON 26 NOVEMBER 2006 BY THE BOARD OF STUDIES (POST GRADUATE) IN HISTORY

The revised courses for M. Phil. (History) mentioned below are recommended for introduction from academic session 2006-7, beginning October 2006.

Each student will be required to successfully complete 2 (Two) courses of 100 marks each, with a total of 200 marks in the first semester. In the second semester the student shall make a seminar presentation and write a dissertation on a previously approved topic. Thereafter the student will be required to appear at a viva voce examination. The dissertation and viva voce shall be of 100 marks (75+25). The total number of marks for the M. Phil. Degree will be 300.

The following courses have been approved by the Board of Studies (PG) at its meeting held on 26 November 2006.

1. Course I: Historical Theory
2. Course II: Trends in Indian Historiography
3. Course II (A): Literature and Thought in Early India

NOTE REGARDING COURSE OPTIONS IN M. PHIL.

- I. Course I (Historical Theory) shall be compulsory for all students.
- II. Course II (Trends in Indian Historiography) shall be compulsory for all students with M.A. level specialisation in medieval or modern Indian history.
- III. Students with M.A. level specialisation in ancient Indian history or ancient Indian history, archaeology and anthropology may take either Course II (Trends in Indian Historiography) or Course II (A) (Literature and Thought in Early India).

Item No.-1: To consider the UGC Model Curriculum for PG courses in Economics given in UGC Booklet sent by Academic Branch of H.P. University vide their letter No. 6-38/2002-HPU(Acad), dated 13.02.2002.

The Board of Studies (PG) in Economics compared the existing post-graduate Economics syllabus of H.P. University with that of the Model Curriculum of UGC and found that the existing M.A. Economics course syllabus of the H.P. University are by and large of the same level as those suggested by the UGC Model curriculum. Hence, the BOS recommended that there is no need to change the existing syllabus of M.A. (Economics) courses at this point because it was only introduced and upgraded two years ago after consulting the syllabus of various universities of North India including the Delhi University.

However, the Board of Studies felt that the following changes be made:-

- (a) That without changing the course syllabus the existing semester wise course sequence of M.A. (Economics) and M.A. (Business Economics) should be changed as given in Annexure - I.
- (b) The distributions of 100 marks of each paper of M.A. (Economics) and M.A. (Business Economics) should be specified as given below with the clear-cut instructions for the paper-setters and the candidates:-


